The Public Works Committee for the City of Reedsburg convened for a special meeting, on September 16, 2020 at 5:30 p.m. in the Reedsburg Center Conference Room with the following members present:

Members Present: Dave Knudsen, Calvin Craker, Charlie Backeberg, Jamison Sporakowski and Phil Peterson

Also Present: Steven Zibell, Chris Kleinschmidt, Amy and Ben from Town & Country Engineering

Motion by Backeberg seconded by Knudsen to approve the minutes from August 19, 2020 meeting.

Ben from Town and Country presented future loading projections for the wwtp. Presented were numbers with the City taking all of the industrial loads or doing a pretreatment system for some of the industries. Ben stated the option to take all future loading to the existing plant would be very difficult due to the amount of space needed. Ben stated an option may be to do a pretreatment facility operated by the City at a different location along with expanding what we can at our existing location. Another option to look at is to relocate the whole plant. There was discussion amongst the members about different options and if they felt the proposed loading projections are reasonable. Knudsen thought it would be wise to look at a new location since the existing plant is in a flood plain and has flooded once in and close to flooding a second time. Ben stated if the committee was fine with their proposed projections they would submit this to DNR for their approval and then come back to us with options and cost projections. No formal action was taken at this time but the committee instructed Town and Country to keep moving forward with the Facility Plan Projections.
