There was discussion of the old City Shop site and what to do with the site along with the buildings. Zibell stated he would like to keep the salt shed if possible for winter use. The committee felt that all the building should come down except the salt shed and the concrete slab under the larger south bay. Zibell stated staff would probably start moving things out to the new shop around x-mas time and hopefully be moved in by end of January. Zibell also stated Prestige Landscaping will be renting out the old shop until we are able to demo it. The committee felt the best may be to put the buildings out for bid for purchase and removal with a time frame for removal. Zibell stated he would work with Becker on this and bring back proposals hopefully next spring early summer.
